**The LESSEE agrees to be responsible for the first \$5000.00 of any damages done to** trailer, and to be entirely responsible for all damages or injury caused by any person or property of others, also to replace any loss or damage incurred to said articles, while in the custody of the LESSEE. In case of trailer breakdown, LESSEE agrees to do their utmost to have necessary repairs made so trailer can be towed home by LESSEE. In case of major problem, LESSOR must be contacted immediately. Receipts and where possible, damaged parts must be produced by LESSEE in order to be compensated for any monies paid out.

If for any reason trailer is not available for time reserved LESSOR is liable to extent of deposit only or substitution of another unit.

It is also the LESSEE's responsibility to ensure that the Grey and Black tanks are dumped and the septic hose cleaned before traileed is returned. If we have to empty the tanks and clean septic hose there will be an additional charge of \$100.00 which will be added to your rental total.

**BOOKING DEPOSIT TRANSFERRED TO THE DAMAGE DEPOSIT**

A booking deposit of \$250 shall be required from the LESSEE at the time the LESSEE books the trailer for the rental period by credit card. If payment is made by cash or cheque, please forward payment within 2 weeks of booking. At the commencement of the rental, the booking and administration deposit shall be transferred to the Damage Deposit. After return of the trailer, inspection will be completed and the damage deposit will then be applied to balance owing.

**\*CANCELLATION POLICY**

***IF for any reason you cancel The \$250 deposit taken at time of booking will not be refunded; it will be applied to lost rental funds due to cancellation.***
